Also, all that certain piece, parcel or lot of land situated, lying and being in Greenville Township, Greenville County, State of South Carolina, near the Eastern corporate limits of the City of Greenville, and being known and designated as Lot No. 21 as shown on plat recorded in the R. M. C. Office for Greenville County in Plat Book "C", Page 99, and being more fully described as follows to-wit:

Beginning at a pin on Mt. Zion Ave., corner of Lot No. 20, and running thence with line of Lot No. 20, N. 83 1/2° E. 114 feet to an iron pin on a 10 foot alley; thence along said alley 50 feet, more or less, to an iron pin; corner Lot # 22; thence S. 84° E. 114 feet to a pin on Mt. Zion Ave.; thence with Mt. Zion Ave. 48 feet to the beginning, and being the same lot of land conveyed to J. W. and Elizabeth Duckworth by E. E. Watson by deed dated May 17, 1923, which deed is recorded in the R. M. C. Office for Greenville County in Deed Book Vol. 97 at Page 417."

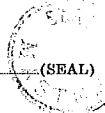
