Commencing at a pin in the northern edge of said Scuffletown or Woodruff Road (surface hereinafter) opposite Conyers and Gower property, and running thence along line of land of Mrs. Fizzie Duffitt (M. C. Duffitt), N. 16 1/2 E. 23.77 chains to an iron pin c. m.; thence S. 61.00 W. 14.50 chains to a stone c. m.; thence S. 5 1/2 E. 20.15.65 chains to an iron pin in northern edge of said Scuffletown or Woodruff Road, thence S. 83 1/2 E. along said road 21.12 chains to the beginning corner, said land being bounded on the north by Gordon lands; on the east by lands of Fizzie Duffitt; on the south by surface titled head and in the west by lands of J.
