in the State aforesaid, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release, unto the said C. Douglas Wilson,

all that piece, parcel <sup>tract</sup> of land in Cleveland Township, Greenville County, State of South Carolina,  
on waters of Headforemost creek and having according to a recent survey thereof, made by Dalton & Neves, Engineers, March 1934, the following metes, bounds, courses and distances to-wit:

Beginning at a point in the center of Headforemost Creek, joint corner of property herein conveyed with the property of Newman, Myers and grantee herein, and running thence in a northerly direction up and with the meanderings of headforemost creek, and with the center of said creek as a line, 783 feet, more or less, to a point in the line of the Cleveland property, which point is in the center of said headforemost creek; thence with the Cleveland property N. 82-30 E. 425 feet more or less to an iron pin; thence S. 21-45 E. 665 feet to an iron pin in the line of the Ragsdale property; thence S. 77-15 W. 36.8 feet to an iron pin; thence N. 40-00 W. 88.2 feet to an iron pin; thence S. 49-30 W. 255 feet to the point of beginning.
