All that certain lot of land situate at the south west corner of Burnie and Wardlaw Streets, in the City of Greenville, County and State aforesaid, known as Lot Number One (11) on the plat of Laddson A. Mills property made by Dalton & Neves dated May, 1930, and recorded in Plat Book 6, page 272, P. M. C. office for Greenville County, and being more particularly described as follows:
