all that piece, parcel or lot of land in

Township, Greenville County, State of South Carolina.

All that certain tract of land in Chick Springs Township, Greenville County, State of South Carolina, on both sides of Lee Road, and having the following metes and bounds according to a plat made by F. Earle Steerman Surveyor August, 1930.

Beginning at an iron pin on Warehouse Road, corner of Wm S. Edwards' tract and running thence S. 1° 26' 35.88 Chs to an iron pin on Lee Road, thence N. 71° 34' E. 18.03 Chs along said road to an iron pin; thence N. 68° 34' E. .48 Chs to an iron pin; thence continuing with said road N. 72° 34' E. 19.85 Chs to an iron pin, corner of Vance Edwards' land, thence with line of his land S. 13° E. 20.01 Chs to an iron pin; thence N. 80° W. 44.42 Chs to an iron pin on Lee Road; thence with Lee Road N. 71° 34' E. 2.95 Chs to an iron pin; thence N. 10° E. 39.17 Chs along line of other lands of B.
