All that lot of land just outside the corporate limits of the city of Greenville, S.C., near the southern Railroad and West Washington Street Extension known as Lot no 2 or plot of property of the Estate of Julia May Speight, made by Dalton & Nevins March 1935 and revised June 1935, and having the following courses and distances according to said plat.
