All that certain piece, parcel or tract of land situate near Oneal, in On eal Township, Greenville County, State of South Carolina, having the following metes and bounds: Beginning at a stone in the Rutherford Road and runs S. 50 E. 7.50 chains to W. O. Near a spring; thence down the spring branch with its meanders to a maple 3x 3x; thence S. 58 W. 25.40 to a maple 3x 3x in one other branch; thence up said branch with its meanders to an ash 3x on the Greenville-Rutherfordton Road; thence with said road to the beginning, containing Twenty-nine (29) acres, more or less, being the same tract of land conveyed to James E.
