All that certain piece, parcel or lot of land, situate, lying and being in Greenville Township, County and State aforesaid, near the City of Greenville and on the Rutherford Road, described by metes and bounds, as follows, to-wit: Beginning at a stake at the corner of the land owned by A. G. New and that sold to A. Speagle; running thence along the Rutherford Road N. 55-6 E. 50 feet to an iron pin marking the land as sold to W. D. Browning; thence N. 34-47 W. 200 feet to a stake; thence S. 55- W. 50 feet to a stake on the line of the land sold to A. Speagle; thence along the line of the land sold to A. Speagle S. 34-47 E. 200 feet to the beginning corner.

2. All that other certain parcel or lot of land situate, lying and being in Greenville Township, County and State aforesaid, and on the Rutherford Road, described by metes and bounds; as follows: Beginning at a stake at the corner of the land as deeded to Julius Heyward and the corner of the lot of land as deeded to Mrs. Carrie Adams; and running thence N. 34-47 W. 213.4 feet to a stake; thence N. 54-32 E. 8 feet to an iron pin on corner of the lot of land sold to W.
