All that piece parcel or lot of land in Greenville
Township, Greenville County, State of South Carolina,
in the City of Greenville on the south side of East Stone
Avenue, and having, according to a plat thereof prepared
by C. M. Farnam, Jr., Engineer, January 14, 1926, the following
metes and bounds, to-wit:
