LEASE

- (1) That, R. F. - (3) The term of this lease is for 37 days ending Aug. 31st, 1935 at the rate of Twelve Dollars (\$12.00) per week payable in advance first of each week. And for any reason the lasse e desires to terminate the lease satisfactory arrangements will have to be made with les sor.
- (4) The lessee hereby agrees to make no changes or alterations in the building or equipment from the above des cribed premises; the leasee is not to sub rent any of the above premis es or equipment without written consent of the lessor. At the expiration or termination of this lease, it is agreed that the lessee, shall return the above premises and equipment in as good condition as accepted, wear and tear excluded.
- (5) It is also agreed by the lessee that the lessor shall have the right to enter premises and inspect equipment at any time desired. And if there is default in upkeep of equipment or premises the lessor shall have the right to expell the lessee or persons from premises and equipment on written notice. And it is agreed by the lessee to quit and deli ver up premises and equipment peacefully and quietly to lessor whenever eny of the above conditions are violated or this lease terminates.
