Wood died seized and possessed, save and excepting that certain piece, parcel or lot of land situate, lying and being in the County of Greenville, State aforesaid, in Chick Springs Township in the nown of Greer on the South side of Emma Street known as the home place of the said John D Wood, now deceased.

This deed is executed in accordance with the Agreement hereinabove referred to, made between Pearl Haynes Wood, Mae Wood Robinson, Helen Wood Hendrix and Richard Haynes Wood, heirs and beneficiaries of the property hereinabove described under the will of John D. Wood, deceased, on the 17th day of October, 1935. which Agreement is recorded in the Register of Mesne Conveyance Office for Greenville County in Deed Book 181, page 304, and in the office of the Clerk of Court for Laurens County in Beed Book 64, page 401.
