(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold, and Released, and by these presents do Grant, Bargain, Sell and Release unto the said

Elizabeth Louise Wilson.

"All that tract of land containing 28-1/2 acres, more or less in Grove Township, Greenville County, S. C., on the Georgia or Spartanburg Road, bounded by lands of J. H. Slaten, W. B. Bennett and E. B. Garrison, and having the following courses and distances according to survey and plat by W. J. Riddle, surveyor, September 13, 1933; beginning at an iron pin on the Old Georgia or Spartanburg Road, corner of Frank Rogers, thence N. 30-1/2 W. crossing the new Georgia Road 4.57 to iron pin corner of Frank Rogers; thence still with his line N. 53-1/2 E. 8.98 to iron pin; thence still with his line N. 36 W. 5.21 to iron pin; thence still with his line N. 11-1/2 E. 4.31 to iron pin, corner of J. H. Slaten; thence with his line S. 68-1/2 E. 10.87 to iron pin; thence still with his line N. 17-1/2 E. 2.00 to stone; thence crossing the branch S. 85-1/2 E. 6.88 to stone, corner W. B. Bennett; thence with line of W. B. Bennett and E. B. Garrison crossing the Georgia Road S. 16 E. 11.86 to iron pin; thence with old Georgia Road the following four courses to the beginning: S. 77 W. 5.00 S. 62-1/2 W. 1.74; S. 83-55 W. 12.33; and S. 82-1/2 W. 4.30 being the same land conveyed to Nellie Rice by May Bennett by deed dated Nov. 29, 1930, recorded in book 157, page 178, and in which Nellie Rice conveyed an undivided one-half interest to Homer D. Rice, deed dated July 7, 1932, recorded in Book 161, Page 520.

Subject, however, to a seven-twelfths interest in one acre of the above 28.25 acres, said one acre having the following courses and distances: Beginning at an iron pin on the old Georgia & Spartanburg Railroad at the corner of Frank Rogers' land; thence N. 30-45 W. 4.57 chains to an iron pin at the corner of Frank Rogers' land; thence N. 53-30 E. 1.90 chains thence S. 30-45 E. 5.58 chains to the road bed of the old Georgia and Spartanburg Railroad line; thence S. 82-30 W. 2.10 chains to beginning corner. This deed conveys to the grantee only such interest as the grantor has in the said one acre of land.

This being the same property conveyed to the within grantor by Nellie Rice and Homer D. Rice by deed dated Nov. 9, 1934 recorded in the R. S. C. Office for Greenville County in deed book 179, at page 218."
