in consideration of the sum of Seven Hundred Fifty and no/ea (\$750) Dollars,to me paid by Mrs. Hattie Brownlee Harmonin the State aforesaid, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released and by these presents do grant bargain, sell and release unto the said Mrs. Hattie Brownlee Harmonall that piece, parcel or lot of land in Greenville, Township, Greenville County, State of South Carolina, beginning at an iron post on the southeast corner of Watson and Grace Streets and running thence with Grace Street 21.71 ft. E., 118 feet and 8 inches to an iron post at line of Lower Electric Lanesway, thence with its line S. 17° 55' E., 51 feet to an iron post corner of lot no 10, thence with line of lot no 10 S. 71° 04' E., 118 feet to an iron post on Watson Street, thence with Watson Street 21.40 ft. 51 feet to the beginning corner being known as lot no 9 on plat of the Watson property, recorded in the office of the Register of Mesne Conveyance for Greenville in Plat Book 9, pages 164 and 165.

Grantor reserves the right in behalf of himself his heirs and assigns, for the use and benefit of lots nos 10, 11 and 12, on Watson Street shown in said plat, to lay a sewer line under and across the rear end of the with described lot, closer to the center boundary line than the surface, under the direction of the City Engineer of Greenville and with the privilege of perpetual repair, renewal and maintenance for the benefit of himself his heirs and assigns.

The above described land is a portion of the same conveyed to me by Grace & Griffith and Charles Watson on the 23rd day of October, 1934 deed recorded in office of Register of Mesne Conveyance for Greenville County, in Book 179, Page 271.
