having the following metes and bounds; beginning at an iron pin in road and running thence N. 77 1/2 W. 18.72 to iron pin at branch; thence up meanders of branch N. 13 E. 5.20 to iron pin; thence along branch N. 15 E. 18.90 to stone (at mouth of Spring Branch); thence S. 5 1/2 E. 17.60 to iron pin in edge of A. H. King's yard; thence S. 4 1/2 W. 16.12 along road to the beginning corner, and containing 34.65 acres, more or less, and being a portion of tract of land conveyed to J. H. Pike by W. F.
