Going (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Oliver F. Going and James W. Going, all my right, title and interest in and to the following described property, to-wit:

All that piece, parcel or lot of land in Greenville County, State of South Carolina, in the City of Greenville, on the South side of Jenkins St.; Beginning at an iron pin on Jenkins St. and running thence S. 33-7 W. 129 feet to an iron pin; thence N. 68 W. 42½ feet to an iron pin; thence N. 26-2 E. 128½ feet to an iron pin on Jenkins St.; thence S. 68 E. 55 feet with Jenkins St. to the beginning corner. Being the same lot conveyed to O. F. Going, by Thos. I. Charles by deed dated Jan. 14, 1911 and recorded in the R. M. C. Office for Greenville County in Deed Book 11 at page 7.
