the receipt whereof is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto the said *J. L. M. Daniel*, all that certain piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina, known and designated as lot No. 96 as shown on plat of property of Mt. View Land Company, recorded in the Office of R. M. C. for Greenville County in Plat Book A at page 396. Beginning at a stake on the east side of Chandler St. 350 feet north from Martin St. are the north west corner of lot No. 97 thence along line of said lot, S. 29 $\frac{1}{2}$  E. 148 feet to a stake on a ten foot alley; thence with said alley N. 11 $\frac{1}{2}$  S. W. 50 feet to a stake on the southeast corner of lot No. 96; thence with line of lot mentioned lot N. 89 $\frac{1}{2}$  W. 148 feet to a stake on Chandler St.; thence with said street S. 11 $\frac{1}{2}$  E. 350 feet to the beginning corner.
