the receipt whereof is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto the said

*J. B. Ordens and Etta Hudkins Ordens*:

All that piece parcel or lot of land in the County and State aforesaid on McIver Street Alta Vista, known and designated as Lot No. 96, on plat of Alta Vista, recorded in R. M. C. Office in and for Greenville County in Plat Book "B" at page 20.

Beginning at an iron pin on the North side of McIver Street at point corner of Lots 97 and 96; thence N. 4.04 E. 183.7 feet to iron pin; thence S. 84-41 E. 71 feet to an iron pin (line of Lot No. 95); thence S. 4.04 W. 183.9 feet to iron pin on McIver Street; thence along McIver Street N. 84-35 W. 71 feet to beginning corner. *11* X
