Beginning at the corner of lot #4, on the Northeast
 side of Park Road and running thence with the line
 of that lot N. 74-50 E. 182.8 feet to a point; the joint corner
 of lots #4 and #5, thence S. 24-05 E. 183.3 feet to the corner of
 portion of lot #5, reserved by grantor; thence along the line
 of that lot to a point on Park Road 196.7 feet distant from
