Know all men by These Presents, That we, the undersigned, in the State aforesaid, in consideration of the sum of Eight Hundred, ninety two and 68/100 (\$892.68) Dollars, to us in hand paid at and before the sealing of these presents by Augusta Road Water and Sewer Sub-District (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Augusta Road Water and Sewer Sub-District, its Successors and Assigns:

All our right, title and interest of whatsoever nature in and to 1,950 feet of water line in the County of Greenville, State of South Carolina, laid along M^r Daniel Avenue, and extending from the City limits of Greenville to the Augusta Road, together with all fittings which go to make up the water system including hydrants, valves, and all fixtures. It is understood that this conveyance includes only the main or trunk line and does not include lateral or house lines leading from the main or trunk line.

Together with all and singular the Rights, Mortgages, Hereditaments and Appurtenances to the said Premises belonging, or in anywise incident or appertaining.

To have and to hold all and singular the Premises before mentioned unto the said Augusta Road Water and Sewer Sub-District its successors and assigns forever.

And we do hereby bind ourselves and our Heirs, Executors and Administrators to warrant and forever defend all and singular the said Premises unto the said Augusta Road Water and Sewer Sub-District, its successors and assigns against ourselves and our Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.

Witness our hands and seals, this day of January, in the year of our Lord one thousand nine hundred and thirty six in the one hundred and sixtieth year of the Independence of the United States of America.
