Beginning on a stone 34 with R. Dawkins "Cage Place" thence N. 9 E. 26.35 chains to stone 3X formerly Dr. D. on east bank of Cedar Shoals Creek; thence N. 2 1/2 W. 30.15 chains to stone 3X with S. A. Norwood; thence N. 51 W. 16.60 chains to stone 3X; thence S. 3 W. 36.34 chains to a stone 3X; thence S. 75 3/4 E. 11 chains to the beginning bounded by lands now or formerly of R. Dawkins, S. A. Norwood and E. H. Acker.
