All that piece, parcel or tract of land, situate lying and being in the County and State aforesaid, in Bates Township, about one mile above Travelers Rest on the South East side of the Hendersonville-Greenville Highway, and has the following metes and bounds, according to a survey of said land made by George A. Ellis, Surveyor, on the 4th day of December, 1936.

Beginning at an iron pin on the South East side of Highway, joint corner with Nelson; thence S. 38-30 E. 858 feet to Grassy Branch; thence up said branch, S. 61 W. 45 feet; thence N. 86 1/2 W. 145 feet; thence N. 88 1/2 W. 130 feet; thence S. 82 1/2 W. 217 feet; thence S. 76 1/2 W. 270 feet; thence S. 61 W. 135 feet to corner on land of Love estate; thence N. 9-40 E. 594 feet to iron pin on the South East line of said Highway; thence N. 55-30 E. 398 feet along the South East line of said Highway to the beginning corner.
