on the Reservoir Road, containing 68/100 acres, according to survey and plat of W. J. Riddle, Surveyor, November 19th, 1886, and having the following courses and distances according to said plat;

Beginning at iron pin in branch on line of Lot No. 8 of the Amanda Young property, running thence S. 87-16 E. crossing Reservoir Road 103 feet to stake; thence N. 29-33 E. 224 feet to stake; thence N. 28-46 W. 55 feet to stake in branch; thence branch the line S. 50-30 W. 387 feet to iron pin, beginning corner.
