That one lot of land in which springs Township, just north of the city of Mill, said county and State, and on the western side of the Mastella Road, and having the following course and distance:

Beginning at an iron pin on the western edge of the said Mastella Road at the corner of the Campbell lot, and running thence with Campbell line S. 73-00 W. Two hundred twenty-five (225) feet to an iron pin near an old road, thence with the said old road S. 28-35 E. ninety-four and eight-tenths (94.8) feet to an iron pin on the eastern edge of the said old road; thence N. 75-30 E.
