Beginning at a point on the Western edge of Augusta Road, which is a joint corner with
property owned by Mrs. Bernice Allgood Martin, being conveyed by her to the Grantees herein,
which point is 20.1 feet from the corner of property now or formerly owned by the Sullivan
Estate; and running thence the joint line between me and Mrs. Martin S. 42-45 W. 77.6 feet to
the joint corner between me and Mrs. Martin; thence along the joint line between us N. 46-15 V
20.5 feet to a point in said joint line which would constitute the intersecting point of a
line running from Augusta Street along the edge of the Southern brick wall of my store house
