TITLE TO REALESTATE

STATE OF SOUTH C AROLINA, COUNTY OF GREENVILLE.

Martin, the receipt where of is hereby acknowledged, have bargained, sold and released and by these presents do grant, bargain, sell and release unto the said Edgar H. Martin, Sr., Wilbur T. Martin and James M. Martin, the said Walker Martin Funeral Home, Inc., having assigned its bid in writing to the said Edgar H. Martin, Sr., Wilbur T. Martin, and James M. Martin, all that certain piece, parcel or lot of land hereinafter described to-wit:

"All that certain piece, parcel, or lot of land together with the improvements thereon, situate in the Town of West Greenville, County and State aforesaid, known as the Butler Dixon (Dickson) property, situate on Packs Alley, conveyed to the said Butler Dixon (Dickson) by Mary L.
