Robinson, the receipt whereof is hereby acknowledged, HAVE granted, bargained, sold and released, and by these Presents, DO grant, bargain, sell and release unto the said W. Robinson and his Heirs and Assigns.

All (3) A tract of five and one-fourth acres, more or less (5.35) acres in deed) in Greenville County State aforesaid, about three or four miles from the City of Greenville, located on the west side of the White Horse Road and being more fully described in deed of Albert W.
