Bouras that certain stock of goods and merchandise now in store-room No. 603 Buncombe Street, City of Greenville, said County and State, of which I am the true and lawful owner and of which I have full power, good right and lawful authority to sell, and I agree to be responsible for all debts against same or against Colonial Cafe at said address prior to the execution of I, William P. Bouras, agree to the foregoing.

That I, Marie E. Lask, Lessor, in consideration of the rental hereinafter mentioned, have granted, bargained and released, and by these presents do grant, bargain and lease unto William P. Bouras, Lessee, the said premises No. 603 Buncombe Street, said City, County and State, and the furniture and fixtures now therein and listed in Schedule attached hereto, marked "Exhibit A" for the term of Seven (7) months, beginning on November 1, 1937, and ending May 31, 1938; and the said William P. Bouras, Lessee, in consideration of the use of said premises for the said term, promises to pay the said lessor a monthly rental, in advance, except for the month of November, 1937, that is, Forty (\$40.00) Dollars per month on the 1st day of each month beginning with December 1st, 1937.

No.repairs are to be made in any way.

I, William P. Bouras, agree to take the premises and furniture and fixtures as they are, agree to pay all water, light, gas and other bills from this date and assume all responsibilities in connection with premises, furniture and fixtures and business from this date.

I, Marie E. Lask, agree to be responsible for all bills in connection with premises, furniture and fixtures and business prior to this date.

Destruction of premises by fire or other casualty shall terminate this lease.

If rent is not paid promptly on the 1st day of each month in advance, as stipulated hereinabove, lessor shall have the option of terminating this lease without further notice; and such failure to pay rental promptly on the 1st of each month, in advance, shall be a breach of this lease contract, and lessor shall be entitled to the immediate possession of premises.

To Have and to hold the said premises, furniture and fixtures unto said lessee, his executors and administrators for said term.

However, lessee agrees not to sublet nor sublease said premises and furniture and fixtures, without written consent of lessor.
