M. C. Office for said Greenville County, composed of two tracts, one of fifty (50) acres, which was conveyed to Gabriel Thompson by W. P. Cunningham, Executor of the Will of Isham J. Ward, by deed dated December 1, 1896, recorded in Deed Book ZZ, page 922, R. M. C.
