Hopkins the then delinquent tax collector of the State and County aforesaid, did on the llth day of May 1936 seize and take exclusive possession of the said property against which said taxes were assessed and levied, as hereinafter described, and on Sales Day of the month of June 1936 during the usual hours of sale, after due advertisement, sell the same to M. A. Richards and his heirs and assigns, the purchaser, hereinafter known as grantee", and the highest bidder at such sale, for the sum of Twenty seven and 38/100 dollars and gave a receipt for said purchase money to him; and

WHEREAS, more than twelve months have elapsed since the date of said sale, and the defaulting taxpayers, or any other party interested, have failed to redeem said land so sold for taxes;

NOW, THEREFORE, KNOW ALL MEN BY THESE PRESENTS That I, M. L. Ashmore Delinquent Tax Collector of and for the County and State aforesaid, in consideration of the premises, and the sum of Twenty Seven and 38/100 (\$27.38) Dollars to me paid by the said grantee M. A. Richards have granted, bargained, sold and released, and by these presents do grant, sell, bargain and release unto the said grantee M. A. Richards their heirs and assigns:

Together with all and singular the Rights, Members, Hereditamnets and Appurtenances to the said Premises belonging, or in anywise incident or appertaining,

To have and to hold all and singular the premises hereby granted, with the appurtenances, unto the said M. A. Richards his heirs and assigns, forever, according to the form in force and effect of the laws and usages of the State of South Carolina in such cases made and provided.
