KNOW ALL MEN BY THESE PRESENTS, THAT WE, Franklin Real Estate and Investment Company and J. E. Sirrine, Trustees, in the State aforesaid, for and in consideration of the sum of one Thousand two hundred fifty-eight and no/100 (\$1,258.00) Dollars being the full, true and complete consideration, to us in hand paid at and before the sealing of these Presents, by UNITED STATES OF AMERICA (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said United States of America or its Assigns forever:

All that certain tract, piece or parcel of land lying in Cleveland Township, Greenville County, South Carolina, approximately 9 miles north of Marietta, South Carolina on U. S. Highway #276 and beginning at a point in center of said highway and running thence with highway north 89° west 782 feet, thence with highway South 81° 30' West 290 feet, thence with highway South 70° West 984 feet, thence with highway and running North 17° 30' West 150 feet, thence North 72° East 512 feet, thence North 21° 30' West 945 feet, thence North 33° West 470 feet, thence South 76° East 1000 feet, thence North 32° 30' East 595 feet, thence North 13° 30' West 718 feet, thence North 73° East 528 feet, thence South 34° East 417 feet, thence South 12° 30' West 400 feet, thence South 34° East 390 feet, thence South 82° East 160 feet, thence South 6° 30' East 477 feet, thence South 52° West 500 feet, thence South 6° 30' West 106 feet, thence South 4° 30' East 93 feet, thence North 81° East 455 feet, thence South 0° East 96 feet, thence South 18° 30' East 162 feet to the beginning, and containing 62.9 acres exclusive of area included in righty-of-way of State Highway Department, all as shown by plat of proposed park on Geer Highway dated August, 1936, prepared from survey of James Reynolds, Jr., which plat is attached to copy of original abstract.

The grantors herein reserve a right-of-way extending from the highway known as Road No. U. S. 276, and extending back across said property for a distance of approximately 150 feet, to be used as a private entrance way to a private living establishment, the exact location of said entrace way to be determined by mutual agreement of the grantors and grantee herein.
