ASSIGNMENT FOR THE BENEFIT OF CREDITORS.

Wells, the receipt whereof, is hereby acknowledged, have granted, bargained, sold, assigned, transferred and set over, and by these presents do grant, bargain, sell, assign, transfer and set over unto the said J. M. Wells, all and singular the lands, tenements, hereditaments and appurtenances, goods, chattels, stocks, promissory notes, debts, choses in action, evidences of debt, claims, demands, property and effects of every description belonging to said company, wherever the same may be situate, and especially all:

The stock, merchandise, goods, fixtures, equipment and any other property now located in or owned by the business known as C. H. Talley Lumber Company situate at #421 West Washington St., Greenville, S. C.

To Have and to Hold all and singular the said property unto the said J. M. Wells, in trust, to sell and dispose of the same, and to collect, sue for and demand, receive and recover all such sums of money as may be or become due, owing and payable on said promissory notes, debts, choses in action, evidences of debt, claims and demands, and then in trust to apply the proceeds arising from the same as follows:

First: To pay all lawful costs and expenses of executing the trust hereby created. Second: To pay, after such property and sums as shall be adjudged to be exempt from levy and sale, pro rata to all such creditors as shall accept the terms of this assignment and execute a release for their claims within thirty days after notice hereof.
