A lot or parcel of ground in Graceland Cemetery, Greenville County, S. C. designated as the rear one-half of Lot No. 472, Section No. 8, containing 100 square feet, more or less. It is distinctly understood that said 1/2 lot is to be used exclusively for the burial of human bodies of the white race, and is sold and conveyed subject to all rules and regulations of the Greenville Cemetery Association and any additions or amendments for the government of the cemetery which may hereafter be adopted.

The above described land is the same conveyed to me by Mrs. Josie C. Morrow on the 23rd day of April 1938, deed recorded in office of Register of Mesne Conveyance for Greenville County, in Book X, Page X

TOGETHER with, all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging or in anywise incident or appertaining.

TO HAVE AND TO HOLD, all and singular, the premises before mentioned unto the said O. L. Campbell his heirs and assigns, forever.

AND I do hereby bind my heirs, executors and administrators to warrant and forever defend all and singular the said premises unto the said O. L. Campbell his heirs and assigns, against me and my heirs, and every other person whomsoever lawfully claiming, or to claim the same, or any part thereof.

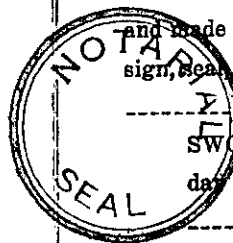
