All of that parcel or tract of land in Highland Township of Greenville County, State of South Carolina, containing thirty-four and fifty-seven one-hundredths (34.57) acres, more or less, lying on road leading from W. P. Morrow place to Pleasant Hill Church and having the following courses and distances, to-wit:
