B. Aiken, and Arthur Aiken

All our right, title and interest in and to all that piece, parcel or tract of land situate, lying and being in the County of Greenville, State of South Carolina and near the limits of the City of Greenville near the Southern Railway and on the extension of Highland Avenue as it crossed the railroad tract before the overhead bridge was built. Beginning at an iron pin at the corner of a street called Johnson Street, according to a plat made by W. A. Hudson, Surveyor, and on the 30th day of December, 1904, and runs thence S. 49½ E. 70 feet to an iron pin; thence N. 33½ E. 161 feet to a stake; thence 68 W. 106 feet to a stake on Johnson Street; thence S. 19 W. 132 feet with Johnson Street to the beginning corner and adjoining lands of T.
