C., the receipt whereof is hereby acknowledged, do hereby release and discharge the said City of Greenville, its successors and assigns, from all claims for damage of any nature whatsoever by reason of the installation and construction of said second pipe line which is to be laid so that the center line thereof will not be further than 35 feet from the center line of the old pipe line. The compensation hereinbefore named constitutes payment for all privileges and rights hereby granted and for all damages arising from the installation and construction of

Wilkins on the north; by lands formerly owned by Tom Guest on the East; by lands of Mrs. I. S. Epps and the estate of Issac S. Epps, on the South; on the West by other lands of the Grantor herein.
