

## TITLE TO REAL ESTATE

37530 PROVISIONS—JANUARY 1938—GREENVILLE

STATE OF SOUTH CAROLINA, )  
 COUNTY OF GREENVILLE. )

WHEREAS, W. A. Allison on the 5 day of September, 1925, executed and delivered to the City of Greenville, S. C., a right-of-way and easement over all or part of the real estate hereinafter described, and said agreement and easement has been duly recorded in Deed Book, 120 Page 1 R.M.C. office for Greenville County, and,

WHEREAS, the City of Greenville now proposes to construct a second pipe line along and over said lands as permitted under the terms of the said easement agreement heretofore given, and,

WHEREAS, it is desired by this supplemental agreement to specify the location of said second pipe line to be laid and to fix the damage, if any, for such additional rights of use.

NOW THEREFORE, KNOW ALL MEN BY THESE PRESENTS, That I, the undersigned of the State and County aforesaid, the owner--of the property below described, for and in consideration of the premises and of the sum of Fifty & 00/100 Dollars to me in hand paid by the City of Greenville, S. C., the receipt whereof is hereby acknowledged, do hereby release and discharge the said City of Greenville, its successors and assigns, from all claims for damage of any nature whatsoever by reason of the installation and construction of said second pipe line which is to be laid so that the center line thereof will not be further than 35 feet from the center line of the old pipe line. The compensation hereinbefore named constitutes payment for all privileges and rights hereby granted and for all damages arising from the installation and construction of said second pipe line along and over the lands hereinafter described.

A tract of land situated in Bates Township, said County and State, and bounded by lands of Mrs. Henry Duncan and Mrs. Otis Bayne on the north; by L. K. Carpenter on the east by South Saluda River on the South and W. T. Batson on the west.

TO HAVE AND TO HOLD, ALL AND singular the rights and privileges hereby granted and released to the City of Greenville, its successors and assigns forever.

I hereby agree to release and give to the City of Greenville, S. C. actual physical possession of the above described premises not later than the 15 day of December, 1938.
