C., as Trustee, by deed dated June 26, 1936, and recorded in Book 185, page 36; and

Whereas Lucy C. Thomson is the owner of a lot of land on McBee Boulevard, Greenville, S. C., known as a portion of Lot No. 20 of Block N, according to said plat, being the same conveyed to her by Elizabeth E. Beaty by deed dated July 8th, 1938, and recorded in Book 204, page 403; and

Whereas said deeds and said plat provide for an alley extending along the joint side line of Lots Nos. 12 and 13 and along the joint rear line of Lots Nos. 12 and 20, and whereas it is the desire of the parties to this agreement to close said alley entirely, leaving open only for the use of lots Nos. 12 and 13 a common driveway 10 feet in width extending along the joint line of lots Nos. 12 and 13 for a distance of 115 feet from Summer Street;
