has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto
heirs and assigns forever:
All that certain piece, parcel or lot of land on the north side of 20th. Street
in Judson Mills No. 2 Village, in the County of Greenville, State of South Carolina,
being known and designated as Lot No. 6 of Block G as shown on a plat of Judson Mills
No. 2 Village made by Dalton & Neves, Engineers, in March, 1939, which plat is record-
ed in the R. M. C. Office for Greenville County in Plat Book K at pages 1 and 2, and
having, according to said plat, the following metes and bounds, to-wit:
BEGINNING at an iron pipe on the north side of 20th. Street, joint corner of Lots
No. 6 and 7, which iron pipe is 209.5 feet from the northwest corner of the intersec-
tion of 7th. Avenue and 20th. Street, and running thence along the line of Lot No. 7,
N. 14-16 E. 137.2 feet to an iron pipe in the line of Lot No. 14; thence with the line
of Lots No. 14 and 15, N. 86-51 W. 61.2 feet to an iron pipe, joint rear corner of Lots
5 and 6; then ce with the line of Lot No. 5, S. 14-16 W. 125.4 feet to an iron pipe on
the north side of 20th. Street: thence with 20th. Street S. 75-44 E. 60 feet to the
beginning corner.
Rights-of-way and easements over and through the tract of land, of which the above
lot is a part, have been granted to Greater Greenville Sewer District Commission and
to Parker Water and Sewer Sub-district to be used for the purpose of laying and main-
taining sewer and water pipe lines through said land and along the streets and roads,
and easements have been granted to Duke Power Company to be used for placing and main-
