Whereas, Alexander McBee, deceased, left a last will and testament in which he gave Floride Smith McBee, Executrix, implied power and authority upon the consent of Crosswell McBee, to sell the real estate of his estate, which will is on file in the office of the Probate Court for Greenville County in Apartment 348, File 5, and

Whereas by agreement dated October 30, 1937, recorded in the R. M. C. Office for Greenville County in Deed Book 201, page 47, all the devisees have given their express consent and authority to Floride Smith McBee, as Executrix, to sell any part or all of said real estate upon the consent of Crosswell McBee, with full power and authority to make deeds of conveyance,

Now, Therefore,

KNOW ALL MEN BY THESE PRESENTS, That I, Floride Smith McBee, as Executrix of the Estate of Alexander McBee, deceased,

in the State aforesaid
in consideration of the sum of Seven Hundred and no/100 (\$700.00) DOLLARS

to me in hand paid, at and before the sealing of these presents by Miriam Welborn O'Dell

in the State aforesaid, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these presents do grant, bargain sell and release, unto the said Miriam Welborn O'Dell:-

All that certain piece, parcel or lot of land, situate, lying and being on the North side of Perry Avenue in the City of Greenville, County of Greenville, State of South Carolina, and being known and designated as Lot No. 5, as shown on plat of property of McBee Estate, prepared by Dalton & Neves, Engineers, August, 1937, and having, according to said plat, the following metes and bounds, to-wit:-

Beginning at an iron pin on the North side of Perry Avenue, at the joint corner of Lots Nos. 4 and 5, which iron pin is 180 feet West of the intersection of Perry Avenue, and an unnamed street; and running thence with the joint line of Lots Nos. 4 and 5, N. 19-0 E. 175 feet to an iron pin, the rear joint corner of said lots; thence along the line of other property of the Grantor N. 71-0 W. 60 feet to an iron pin, the rear joint corner of Lots Nos. 5 and 6; thence with the joint line of said lots S. 19-0 W. 175 feet to an iron pin on the North side of Perry Avenue; thence with the North side of said Avenue S. 71-0 E. 60 feet to the beginning corner.

This property is sold subject to the following buildings restrictions:-

- (1) That no building shall be erected within thirty-five (35) feet of the front line on Perry Avenue.
- (2) That this lot shall not be sold, rented or otherwise disposed of to any person of African descent or with any percentage of negro blood.
