NOW, THEREFORE, by virtue of the authority vested in me by said deed.

KNOW ALL MEN BY THESE PRESENTS, That I, MILVILLE C. WESTERVELT, TRUSTEE, in the State aforesaid, in consideration of the sum of TWO THOUSAND AND NO/100 (\$2,000.00) Dollars, to me in hand paid at and before the sealing of these presents by Perry Woods (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Perry Woods:-

All that certain piece, parcel or lot of land near the City of Greenville on the South side of the Augusta Road and being a portion of what is known and designated as Lot No. 8 as shown on plat of Augusta Circle, recorded in the R. M. C. Office for Greenville County, S. C. in Plat Book E, page 227, and Plat Book F, at page 23, said lot having the following metes and bounds, to-wit:

Beginning at an iron pin on the South side of Augusta Road, 111.9 feet from the intersection of Augusta Road and Faris Road, joint corner of Lots Nos. 7 and 8, and ruming thence S. 30 W. with the line of Lot No. 7, 271.9 feet to an iron pin in the line of Lots Nos. 7 and 8, at the corner of property formerly sold to Grace C. Whatley by deed recorded in the R. M. C. 1/5/40 Office for Greenville County in Deeds Vol. 205, at page 213; thence N. 55 15 W. 62.1 feet along M. C.
