all that piece, parcel or lot of land in Butler Township, Greenville County, State of South Carolina.

on the North side of a road which is being constructed along the Northern edge of the present Airport property, which road takes the place of that part of the Lowndes Hill Road which now runs through the Northern part of the Greenville Airport Commission property. Said tract of land containing 2.20 Acres, more or less, and being more particularly described according to a Plat thereof prepared by Dalton & Nevers, Engineers, May 1939, as follows, to-wit:

BEGINNING at a stake on the Northern side of the new 40-foot road above referred to, and on line of other property belonging to Greenville Airport Commission, and running thence with the line of its property N. 1-50 E. 192.5 feet, more or less, to an iron pin on line of property of Lena W. Glover; thence with the line of her property N. 66-30 W. 422 feet, more or less, to an iron pin, corner of property of Houston and Symmes and Lena W. Glover; thence S. 4-46 E. 339.5 feet, more or less, to a stake on the North side of said new 40-foot road above referred to; thence with the Northern edge of said road S. 86-19 E. 353.3 feet to the beginning corner, Bounded on the South by said new road, on the East by lands of the grantee, on the North by lands of Lena W. Glover, and on the West by lands of grantors.
