SECOND: That the name of the proposed Corporation is Southern Margarine Co.

THIRD: That the principal place of business is Greenville, S. C.

FOURTH: That the general nature of the business which it is proposed to do is to manufacture and sell, at wholesale or retail, margarine and other products, and to do any and all things incident to the proper management of such business, including the right to buy and sell real estate and personal property of every kind and nature, and to have and exercise all powers conferred by the laws of South Carolina on a corporation formed under the laws thereof.

FIFTH: That the amount of the capital stock is One hundred Thousand (\$100,000.00)

payable in cash.

SIXTH: That the number of shares into which the capital stock is divided is one thousand (1,000) of the par value of One Hundred (\$100.00) Dollars.

SEVENTH: That, after due notice, a meeting of the subscribers was held on the 9th day of September, 1939, at which a majority of all stock in value being present in person or by proxy the following were elected directors:

Dick Briggs, Louis Seel, Joe Britt, H. T. Mills, P. J. VonWeller, J. G. Zahringer, John Murray, B. R. Littlejohn and Louis Ballentine.

EIGHTH: That subsequently there was elected as President H. T. Mills as Vice-President P. J. Von Weller; as Secretary, J. G. Zahringer as Treasurer, H. T. Mills; as Asst. Treas., P. J. Von Weller

NINTH: That all requirements of Article 2, Chapter 153 Code of Laws of South Carolina, 1932, and all amendments thereto, have been duly and fully complied with, 50 per cent, of the aggregate amount of the capital stock having been subscribed by bona fide subscribers, 20 per cent, of the capital stock subscribed having been paid to the Treasurer, and three days' public notice of the intention to file this Declaration with the Secretary of State having been given in Greenville Daily News

a newspaper published in the County of Greenville.

NOW, Therefore, I, W. P. BLACKWELL, Secretary of State, by virtue of the authority in me vested by the aforesaid Code and Acts amendatory thereto, do hereby certify that the said Company has been fully organized according to the laws of South Carolina, under the name and for the purposes indicated in their written declaration, and that they are fully authorized to commence business under their charter; and I do hereby direct that a copy of this certificate be filed and recorded in the office of the Register of Mesne Conveyance or Clerk of Court in each county where such Corporation shall have a business office.
