NOW KNOW ALL MEN BY THESE PRESENTS, That I, Alexandros Kostantenou Maniates (A.K. Manos), of Greenville, South Carolina, United States of America, do hereby revoke, absolutely, fully and wholly, the aforementioned Power of Attorney so made and executed by me to said Demetrion George Leonatrites; and I do declare that said Demetrion George Leonatrites has no longer any power or authority to act as my Attorney and agent under and by virtue of same, nor to sign my name, nor to do any other act or deed mentioned in said Power of Attorney, nor to act for me in my name and stead in any way whatsoever; and I do declare said Power of Attorney to be of no further force and effect and to be henceforth non-existent.
