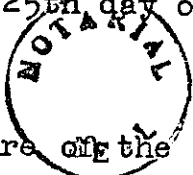
RENUNCIATION OF DOWER.

Hopkins, as incumbent Trustees of School District No. 4-H, Greenville County, South Carolina, and their successors in office, all her interest and estate, and all her right and claim of Dower of, in or to, all and singular, the premises conveyed by that certain deed from her husband, the said John T. Woodside, to J. F. Stoddard, A. W. McDavid and T. W. Stansell, as Trustees of School District No. 4-H, Greenville County, South Carolina, and their successors in office, dated June 25, 1924, and recorded in the office of the Register of Mesne Conveyance, Greenville County, South Carolina, in Book No. 102 of Deeds, at Page No. 299, as later amended by that certain agreement, dated March 26, 1925, which her husband, the said John T.
