Parcel 23: Two tracts of land in Greenville Township, containing 170 acres, more or less; Tract # 1 lying on the South side of Cedar Lane Road, as shown on plat #1 of the Estate of Mrs. A. P. Farr, by Dalton & Neves, September, 1938; and Tract #2 lying on the North side of said Cedar Lane Road, opposite said Tract #1, as shown on Plat #2 of the Estate of Mrs. A. P. Farr, by Dalton & Neves, September, 1938; and being the same two tracts conveyed to the grantor by Wilmot Smith, Conciliation Commissioner, by deed recorded in Vol. 210, page 50; less, however, 1.62 acres sold from tract #1 to J. A. Wyatt by deed recorded in Vol. 213, page 380; and tract of 1.50 acres sold from Tract #1 to J. E. Parcel 25: Two lots of land in the Town of Greer, State and County aforesaid, on the corner of Trade and Randall Streets with a frontage of 51.9' on Trade Street and a depth of 111.9' along Randall Street to a 12 foot alley, being known and designated as lots Nos. 4 and 5, Section B, as shown on plat of property of D. D. Davenport Estate by H. S. Brockman, Surveyor, dated December 8, 1939 and recorded in Vol. K, pages 29 and 30 and being a part of the property conveyed to D. D. Parcel 27: Eight lots of land in the Town of Greer, with a frontage of 139.65' on School Street (formerly Mills Street) and with a depth along Randall Street of 248.6' and being known and designated as lots 3-10 inclusive in Section C, as shown on said plat recorded in Vol. K, pages 29 and 30 and being a part of the property conveyed to D. Parcel 28: Three lots of land in the Town of Greer with a frontage of 75' on the North side of Randall Street and a depth of 109.5' along a 12 foot alley to a 15 foot alley in the rear and being known and designated as lots 1, 2 and 3 of Section D, as shown on the plat recorded in Vol. K, pages 29 and 30, and being a part of the property conveyed to D. D. Davenport by deed recorded in Vol. KK, page 481.

Parcel 29: Nine lots in the Town of Greer, fronting 245.9' on the North side of Randall Street, with a depth of 109.5' along School Street (formerly Mills Street) to a 15 foot alley in the rear and being known and designated as lots 4-12 inclusive of Section D, as shown on the plat recorded in Vol. K, pages 29 and 30 and being a part of the property conveyed to D. D. Davenport by deed recorded in Vol. PP, page 430.

Parcel 30: Two lots in the Town of Greer, fronting 65.5' on the North side of a 15 foot alley with a depth of 70.2' along the rear of the library lot to the property of the B. F.
