O. Holliday of the State of South Carolina, hereinafter called second parties, whether one or more, has granted, bargained, sold and released, and by these Presents does grant, bargain, sell and release unto second parties their heirs and assigns, the following described real estate, to-wit:

That certain tract or parcel of land, situate, lying and being in Dunklin Township, Green-ville County, South Carolina, comprising Forty One (41) acres, more or less, of the former Texa Anna Holliday farm, described as tract No. 2 on a plat of tracts 1 and 2 thereof dated October 21, 1933, on file with The Federal Land Bank of Columbia. Said tract No. 1 being bounded now or formerly as follows: on the North by lands of Owens; on the East and South by lands of Janie Cothran, and on the West by tract No. 1 on said plat, now owned by A. H. Cothran, said lands being a part of a 125 acre tract described in a mortgage from Texy Anna Holliday to the Land Bank Commissioner, dated March 20, 1934, recorded in Mortgage Book 250, Page 105, of the public records of Greenville County.

TO HAVE AND TO HOLD, all and singular, the said premises before mentioned unto the said second parties, their heirs and assigns forever.

AND, first party, its successors and assigns, does warrant and will forever defend the title to the above described property unto said second parties, their heirs and assigns, against itself, its successors and assigns, lawfully claiming or to claim the same or any part thereof.
