All my undivided one-half interest in and to all those certain pieces, parcels or lots of land situate, lying and being in the City of Greenville (having recently been incorporated within the limits of the City of Greenville), County of Greenville, State of South Carolina, being known and designated as Lots No. 2, 3, 5, 14, 15, 16, 17, 18, 19 and 20 on plat of Addition No. 2 to Forest Hills made by Dalton & Neves, Engineers, February, 1939, and having, according to said plat, the following metes and bounds, to-wit:-

Lots No. 14, 15, 16, 17, 18, 19 and 20 on the north side of East Faris Road Extension being described as follows:

Beginning at an iron pin on the north side of East Faris Road Extension at southwest corner of Lot No. 20, said pin being 120 feet east from the northeast corner of the intersection of East Faris Road Extension and Longview Terrace and running thence with the north side of East Faris Road Extension N. 64-30 E. 490.6 feet to an iron pin in line of Earle property; thence with said Earle property line N. 38-00 W. 174.1 feet to an iron pin; thence along the rear line of Lots No. 7, 8, 9, 10, 11, 12 (and 13), S. 64-30 W. 488.4 feet to an iron pin in the rear line of Lot No. 7, corner of property of V. D. Ramseur; thence with said Ramseur line S. 37-09 E. 173.5 feet to an iron pin on the north side of East Faris Road Extension, the beginning corner.

Lots No. 2 and 3 located on the east side of a street extending from East Lanneau Drive to Longview Terrace being described together as follows:

Beginning at an iron pin on the east side of a street extending south from East Lanneau Drive to Longview Terrace, joint front corner of Lots No. 1 and 2 on plat above mentioned, said pin being 160 feet south from the southeast corner of the intersection of East Lanneau Drive and said street, and running thence with the line of Lot No. 1, N. 63-47 E. 170 feet to an iron pin in line of property of Jean R. McKissick; thence with said McKissick line S. 26-13 E. 150 feet to an iron pin, joint rear corner of Lots No. 3 and 4; thence with the line of Lot No. 4, S. 63-47 W. 170 feet to an iron pin on street first above mentioned; thence with the east side of said street N. 26-13 W. 150 feet to the beginning corner.

Lot No. 5 located on the east side of a street extending from East Lanneau Drive to Longview Terrace being described as follows:

Beginning at an iron pin on the east side of a street extending south from East Lanneau Drive to Longview Terrace, joint corner of Lots No. 5 and 6, said pin also being 120 feet north from the northeast intersection of said street with Longview Terrace, and running thence with the line of Lot No. 6, N. 61-07 E. 170.1 feet to an iron pin in line of Jean R. McKissick property; thence with said McKissick property N. 26-13 W. 67.4 feet to an iron pin; thence with the line of Lot No. 4, S. 63-47 W. 170 feet to an iron pin on the east side of said street first above mentioned; thence with the east side of said street S. 26-13 E. 75.4 feet to the beginning corner.
