feet to an iron pin; thence with the rear line of Lots Nos. 42 and 43, S. 88-05 W. 134.5 feet
to an iron pin on the East side of Hawkins Avenue; thence with the East side of Hawkins Avenue,
S. 3-18 E. 54.8 feet to an iron pin on said Avenue; thence continuing with Hawkins Avenue, S.

veyed, but granting and not reserving all house water lines. The grantor further reserves to
itself, its successors and assigns, the right and easement in perpetuity to go upon the land
for the purpose of maintenance, operation and repair of the above mentioned water pipe and
for the purpose of maintenance, operation and repair of the above mentations and release and release or
electric transmission lines as same are now located, to remove and relocate said lines, or
