Brown, deceased, to me in hand paid at and before the sealing of these presents by James W. Brown, Grover L. Brown, Allan S. Brown, Nancy E. B. Caldwell, Willie T. Brown, Grover L. Brown, Allan S. Brown, Myrza D. B. Lynn, Curtis R. Brown, Fearline B. Edwards, Ellen W. Kemp, Bertha W. Campbell, Evie W. Fowler, Azilee W. Turner, and Fred Willbanks, the sole remaining heirs of the said T. B. Brown, deceased, (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said James W. Brown, Grover L. Brown, Allan S. Brown, Nancy E. B. Caldwell, Willie T. Brown, Myrza D. B. Lynn, Curtis R. Brown, Pearline B. Edwards, Ellen W. Kemp, Bertha W. Campbell, Evie W. Fowler, Azilee W. Turner, and Fred Willbanks, the sole remaining heirs of the said T. B. Brown, deceased, their heirs and assigns forever:

That certain tract of land in O'Neal Township, said County and State, containing 67 acres, more or less, and known as the home tract of the said T. B. Brown, bounded by and adjoining lands of the O'Neal School District and of O. K. Bomar on the North; by lands of O. K. Bomar on the East; by lands of E. B.
