TITLE TO REAL ESTATE

That said Landlord has hereby let and rented to the said Tenant, and it has hired and taken from said Landlord, that certain vacant lot of land situate on the East side of North Brown Street, in the City and County of Greenville, South Carolina, fronting said Brown Street 46 and 8/10 feet, more or less, running back from said street in an Easternly direction, 142 4/10 feet, its Southern line, to the Hodges property, and with that property line in a Northeastern direction 43 3/10 feet; thence 142 5/10 feet to Brown Street; fully and more particularly described in deed recorded in Deed Book 208 page 202.

To Have and to hold said described property unto said Tenant its successors and assigns, for the term of four years and one month, beginning the first day of August 1940 and ending the 31st day of August, 1944.

For the use and occupancy of said premises, the Tenant will pay the Landlord Twelve Hundred and Seventy-four, Dollars, for said term, in monthly installments of twenty six dollars, due and payable at the end of each and every consecutive month during said term.

Upon the Tenant paying the rent as provided and keeping and performing all the other terms and conditions herein, it shall have peaceable and quiet possession of said property, but upon failure to do and perform any of them, it shall quit and surrender the property, the Landlord may re-enter and take possession and remove all persons therefrom without suit or process.
